- Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate code of behaviour
- Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in appropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner





The Board considered and approved all policies in relation to the Covid-19 Response Plan.



7. The Board were presented with a detailed listing all school activities and events that took place between January and February. The board noted the significance of these events in promoting the values based ethos of our school.

8. The Principal reported on the following areas:

- Summer Works 2019 - The scheme is completed. The final drawdown of funds will now begin.
- Summer Works Scheme 2020 onwards. -The school has been granted funding under the 2020 Summer Works Scheme. Tender process has been completed and the tenders were scored by the Principal, Sr Eilís Dockery and Noel Merrick of the JMB. Malachy Walsh and Partners was deemed to most successful tender application. One of the tender applications was deemed not compliant. This was because the company did not appear to have suitably qualified personnel noted in their application.

- Death of student from nearby school.
- The school will begin its 2nd, 4th and 5th Year options nights in the coming month.

9. Policies

- The board reviewed the Critical Incident Policy and approved some practical amendments to its content and layout.
- The Principal presented a draft policy on Job Sharing, Career Breaks and Secondment to the Board of Management. The Board noted that the policy should be presented to staff and the Parents Council for before it will approve the policy.

10. Finance

The Principal presented a financial report to the Board of Management during the Ordinary meeting.

- The Principal gave an outline of the status of the Summer Works schemes and noted the bank finances of the school as at 24th February 2020.

11. Child Protection

Principal's Oversight Report. The Principal presented the Oversight Report to the Board under the four headings. The report is included as an appendix to the minutes.

12. Anti- Bullying Report

The Principal reported no incidents warranted reporting.
